ELEPHANY BEER FESTIVAL TO RETURN IN 1997

The Great North Western Beer and Cider festival is set to return next year in a new venue. The festival will be held at Bolton Excel located at Bolton College on Manchester Road and will run from Wednesday 19th March until Saturday 22nd March 1997.

The cost of admission and the opening times have yet to be fixed, but should be announced soon. The festival will feature locally produced ales from micro-breweries along with beers from Scotland. The later selection are not normally available in the local pubs so there should be a wide choice of ales available outside the norm.

Due to the closure of Silverwell Street Sports Centre the festival has not been held for the last few years, but it is hoped that the event will flourish at its new home. EC Threat To Real Ale Choice

In 1990 a law was brought in that ment that tenants of larger brewers were able to buy one cask conditioned beer from the supplier of their choice, since its introduction this law has been very successful. This 'guest beer' was defined as a 'cask conditioned beer' - a term which covers traditional British ale along with various continental ales and lagers. As a result there has been an increase in the number of small brewers providing local beers for local pubs.

In August 1996, the European Commission threatened to take legal action against the British Guest Beer, claiming that it disciminated against foreign beer.

- 1) Beer choice in the british market is wider than any Continental country,
- 2) Over 300 microbrewers rely very heavily on guest beers for their business,
- 3) There are 220 foreign beers on sale in the British market, more than any other serious beer drinking European nation,
- 4) The organisation representing European brewers, the CMBC, has argued that it is happy with the current rule in Britain!

If the law was changed a number of things may happen

- 1) The nationally promoted beers would get most of the guest beer business
- 2) Choice will decrease, with pubs having the same 'guest' on as each other,
- 3) Microbrewers will be forced to close, thus decreasing choice further.

- 1) That the pub serves good quality real ale,
- 2) That the landlord has had the pub for over twelve months,
- 3) That the pub does not serve 'keg' beer or cider using a missleading method of dispense, such as a fake handpump.
